

BACKGROUND

Owner Malarie Taylor could also could apply for a designation which would further narrow down her competition: Economically Disadvantaged Women Owned Small Business (EDWOSB).

Time was Malarie's obstacle. To get started in government contracting, she had to get registered in the System for Award Management and get verified as an EDWOSB. Then, she needed a way to find contracting opportunities that fast and efficient.

SOLUTION

One of the most time consuming aspects of getting compliant for the EDWOSB is the information that needs to be collected. On top of the regular WOSB requirements, Near Me, LLC needed to gather financial information to prove an economic disadvantage. Since USFCR handles numerous EDWOSB verifications, this again was just a routine procedure that could be handled effortlessly.

Near Me, LLC also had access to the Advanced Procurement Portal (APP). APP is an application developed by USFCR meant to simplify the contract search process. Some of its functions also include government CRM and instant notifications for updates via email on new, industry relevant opportunities.

In less than four months after getting registered in SAM and verified as an EDWOSB, Near Me, LLC won their first contract. It was for wax and pinto beans for the Bureau of Prisons.

Near Me, LLC's main offerings consist of property management and landscaping. From USFCR's videos, Malarie learned that it is possible to win contracts with federal agencies that are outside of your industry. The main requirement is that you prove that you have the capabilities to perform the contract itself.
